

# Privacy Policy

## **Data Protection & Privacy Policy**

The Yoga Institute has created this Privacy Statement to demonstrate its commitment to upholding the privacy of visitors to its Web site, amongst other contacts.

In this section of the Privacy Statement, The Cosmic Yoga Institute describes the type of information it collects and how and why it collects such information.

## **Registration**

During registration, users are required to provide their contact information (such as name, e-mail id, country), which The Cosmic Yoga Institute uses to provide requested services for its Web site visitors, to help make surfing this site easier, and provide a more personalized experience on these Web sites. The Cosmic Yoga Institute uses such information to improve its services.

## **Subscription to Newsletters**

Users who wish to subscribe to The Cosmic Yoga Institute's e-mail newsletters, monthly journal, publications are requested to provide their contact information (such as e-mail address, among other details) on the Web site.

## **Contact Us**

The Web site has features where The Cosmic Yoga Institute's customers and investors can submit information to The Cosmic Yoga Institute by using the 'Contact Us' facility. Such submissions include queries, feedback, or other information needed to best respond to specific requests. In addition, The Cosmic Yoga Institute may retain e-

mails and other information sent to it for its internal administrative purposes to help it serve you better.

### **Automatic Data Collection**

The Cosmic Yoga Institute gathers details such as date, time, browser type, navigation history and IP addresses of all visitors to its web sites. It uses this information for its internal security audit log, analyzing trends, for system administration purposes and, also, to gather visitor behavior and usage patterns on the site. The Cosmic Yoga may combine information supplied by an investor/customer during the registration process on the Web site with usage data to learn more about users and their preferences about the content available on the site. The Cosmic Yoga may use this information to tailor services to specific interests of visitors, or to contact visitors about offers from its business associates, which may be of interest to them. The Cosmic Yoga does not disclose this information to third parties.

### **Sharing information**

The Cosmic Yoga does not sell, rent, or lease its customer and investor information, and registration lists to third parties.

The Cosmic Yoga does not share personally identifiable information with third parties apart from parent, subsidiary and affiliate companies. Information may be shared with third parties who are acting as The Cosmic Yoga agents in providing its product(s)/service(s), and who agree to use it only for that purpose and keep the information secure and confidential.

The Cosmic Yoga Institute will also disclose information that it maintains when required to do so by law or, in special cases, when The Cosmic Yoga Institute has reason to believe that disclosing this information is necessary to identify, contact or take legal action

against someone who may be causing injury to or interference with (either intentionally or unintentionally) its rights or property. The Cosmic Yoga Institute may share aggregate information, which is not personally identifiable, with others.

### **Safeguarding Security**

The Cosmic Yoga will take appropriate steps to ensure that personal data is protected from unauthorized access and disclosure, including limiting access to such data only to those employees with a business need to know.
